



Release of All Claims Indemnity for All Third Party Claims

Express Contractual Assumption of All Risks, Waiver of and Release from All Liability for any Negligence

In consideration of joining, participating and/or taking part in any party or program at GOC Enterprises, LLC, dba Air Time Party, the undersigned hereby acknowledges and agrees that:

I(WE) have read, understand and agree to be bound by the stated and customary Rules of Safety and Conduct governing my(our) conduct while using the arena, including but not limited to the inflatable devices, karaoke stage area and party rooms. If, I(we) observe any violation of the Rules of Safety and Conduct or other hazard during my(our) participation, I(we) will bring such violation or hazard to the attention of the nearest official or employee of GOC Enterprises, LLC, dba Air Time Party. I(We) understand that Rules of Safety and Conduct are strictly enforced.

I(We) am aware and understand that the risks, hazards and dangers which can occur as a result of my(our) participation in any activity, include but are not limited to, falling, jumping, landing, performing tricks or maneuvers, colliding with other users, staff, media personnel and spectators. I(We) also understand that these risks, hazards and dangers are further increased when other persons, whether or not of the same age or level of experience or skill, are present at the same time, using the same equipment and the same facility. I(We) understand that the risk of injury from this equipment can be significant, including the potential for paralysis and even death, and while safety rules, equipment and personal discipline reduces the risk, the risk does exist.

As to my(our) participation in any activity, and as to any and all liability for damages which I may suffer or incur due to any cause whatsoever, while in the arena or on the premises, I(we) hereby agree as follows:

a) To **WAIVE** and relinquish any and all claims or causes of action for damages for any loss, claim, damage, personal injury, disability, death, medical and any other type of expense or property damage or loss caused by any negligence by GOC Enterprises, LLC, dba Air Time Party, its officers, directors, stockholders, associates, agents, contractors, managers, employees, volunteers, sponsors, vendors, and any other person or entity in any way associated with it, and promise not to sue or exercise any legal right to seek damages from GOC Enterprises, LLC,

b) To **RELEASE**, absolve and discharge GOC Enterprises, LLC, dba Air Time Party, its officers, directors, stockholders, associates, agents, contractors, managers, employees, volunteers, sponsors, vendors, and any other person or entity in any way associated with it, from any and all liability for any active or passive negligence whatsoever, and for any damages I(we) may suffer or incur, or that our next of kin may suffer, as a result of our participation in any activity, including but not limited to, the risks described herein.

c) To **HOLD HARMLESS AND INDEMNIFY** GOC Enterprises, LLC, dba Air Time Party, its officers, directors, stockholders, associates, agents, contractors, managers, employees, volunteers, sponsors, vendors, and any other person or entity in any way associated with it, from any and all liability for the damages to any Third Party resulting from our participation in any activity.

By this Agreement, it is my(our) intention to relieve GOC Enterprises, LLC, dba Air Time Party, of any duty to me(us) and I(we) do assume the entire risk of any damages which might occur during or as a result of my(our) use of or presence at Air Time Party. The undersigned certifies that he/she/they has no medical condition which would cause participation in activities associated with Air Time Party to be potentially hazardous to his or her health.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THIS RELEASE OF ALL CLAIMS AND INDEMNITY FOR ALL THIRD PARTY CLAIMS, and further agrees that no oral representations, statements, or inducements apart from this agreement have been made by GOC Enterprises, LLC, dba Air Time Party, or anyone else with regard to the subject matter of this Agreement.
